MINUTES OF THE REGULAR MONTHLY MEETING
April 14, 2021

Chairman William Them called the regular meeting to order at 5 PM.

Present at the meeting were Supervisor Them, Supervisor Thomas Thompson III, Supervisor Frank Hoffman, Township Manager, Jon Kulick, Road Master, Todd Maynard Secretary/Treasurer, Michelle Johns.

Visitors were James Lowenstein of the Rocket, Matt Hicks of The Daily Review, and Bob Lebo.

Supervisor Thompson moved to approve the minutes of the previous regular meetings held on March 10th and special meeting held March 30th. Supervisor Hoffman seconded and motion carried with 3 ayes.

Under Old Business:

Under New Business:

1. We heard a presentation via speaker phone regarding WTMA bonds. No action was taken.
2. Greg Roberts subdivision Supervisor Thompson moved to approve subdivision Supervisor Them second, and motion carried with 3 ayes.
3. Road Recommendation to put out for bid. Jon presented to the board what roads he would like to see Double sealcoating this year. Supervisor Thompson motioned to allow Steve Keho of PA DOT get specks and put road work out for bid with no adverse comments from the township. Supervisor Hoffmann seconded and motion carried with 3 ayes.

4. Supervisor Thompson motioned to approve the purchase of a conference phone for the Board meeting room at the office for quoted price of \$549.00 from Ted Darrow. Supervisor Hoffman seconded and motion carried with 3 ayes.
5. Lee Masonry gave us an estimate of \$6,500 to put steps out to the mailbox in front of the office. The steps would nicer to walk to the mailbox, and make the building look nicer from the street. Jon Kulick will ask the Post Office if they would deliver the mail to a box closer to the building off the parking lot. If the post office will deliver the mail to the office, we will hold off on putting the steps in front of the building. Supervisor Hoffman moved to allow Jon to hire Lee Masonry to put in the steps for \$6,500 if the Post office refused to bring the mail to a mailbox in the parking lot.
6. PA DOT offered the township \$516,00.00 to do a full overhaul to PA Ave. and turn back all responsibilities of said road to the township. Supervisor Them moved to accept PA DOT's offer and make all repairs to PA Ave as well as take back all responsibility to PA AVE supervisor Thomas second and motion passed with 3 ayes.
7. There was discussion regarding moving the switches in the office restrooms to sensory lights. No actions were made at this time.

The meeting adjourned at 5:47.
