1. Supervisor Hoffmann moved to approve Supervisor Them to sign 2 resolutions for the reissuance of 2 Guthrie Bonds. Bonds are run through the Progress Authority. With a roll call vote, Supervisor Hoffmann aye, Supervisor Them aye. Supervisor Thompson abstained due to conflict with working for Progress Authority.

2. Engine Brake Retarder issue on Rt 6, Penn Dot approved to post prohibiting use of engine brake retarder through the entire township. Jon will clarify with PA DOT where we will post. The original request was to prohibit use of brake retarders from Rt 6 intersection of Laning Creek Road to the intersection of Rt 6 and Craftmaster Rd, not for the whole township.
3. With a roll call vote for re-zoning of the Pringle property behind Shores Sisters to Pringle lane; Supervisor Hoffman voted nay, Supervisor Thompson, nay and Supervisor Them abstained. The township will not move on with rezoning said area.

Supervisor Hoffmann moved to adjourn, Supervisor Thompson second and motion carried.
