

RESOLUTION No. 2022-02

A RESOLUTION OF TOWNSHIP OF WYSOX, BRADFORD COUNTY, PENNSYLVANIA, TO JOIN THE NBIS BRIDGE INSPECTION CONTRACT AS COORDINATED BY THE BRADFORD COUNTY OFFICE OF COMMUNITY PLANNING AND MAPPING SERVICES FOR THE 2022-2026 BRIDGE INSPECTION CYCLE

WHEREAS, the Township of Wysox wishes to join the 2022-2026 NBIS Bridge Inspection Program for the inspection of certain bridges located within the Township of Wysox as coordinated by the Bradford County Office of Community Planning and Mapping Services;

NOW THEREFORE, be it resolved and it is hereby resolved as follows:

1. The Township of Wysox shall join and participate in the 2022-2026 NBIS Bridge Inspection Cycle for the necessary inspections of bridges within the Township of Wysox.
2. The Township of Wysox agrees that the Bradford County Office of Community Planning and Mapping Services will act as the lead agent for the Township of Wysox for the coordination of inspection during the 2022-2026 inspection cycle.
3. The Township of Wysox is authorized to execute a letter as required by Act 44 in order to participate and join in the umbrella contract which will enable Bradford County to make the necessary inspections of the bridges located in the Township of Wysox pursuant to the 2022-2026 NBIS Inspection Program.
4. If any sentence, clause or section or any part of this resolution is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parties of this resolution.
5. Any Resolution or parts of Resolutions which are contrary to or in conflict with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect.
6. This Resolution shall take effect on the date of enactment set forth below.


