## MINUTES OF THE REGULAR MONTHLY MEETING

Supervisor Thompson moved to approve the minutes of the previous regular meeting held on June 8, 2022 and special meeting held on June 13, 2022, Supervisor Gannon seconded and motion carried with 3 ayes.

Visitors Comments: Cherie Foster voiced concern about the placement of the porta-a-john at the boat launch. Where it is located is very hard for the senior citizens to get to. Jon is going to look into possibly moving the outhouse that is at the park so it is more in between the 2 pavilions.

Charlie Muchichko with concern of the "Jake Brake use on Rt 6 between Sheetz and the Bradford Towne Center, he spoke with a state policeman, who suggested that the township put more sign along rt 6 prohibiting the use of Jake brakes. Charlie also asked about the timing of the red light for the turning lane at Bradford Towne Center, and if we could make the timing for the turning lane longer. Jon has inquired to PA DOT before regarding the timing of red lights, including this particular light. PA DOT sets the timing of the Red lights and the township is told not to tamper with the timing. Jon suggested that Mr. Muchichko call PA DOT and make a complaint about the light.

Mr. Muchichko was also inquiring about trimming along Pringle Lane. Jon Kulick explained that work on Pringle Lane is in process, as Pringle Lane does not belong to the Township until the Resolution is signed into order later in this meeting.

Steve Keho PA DOT supplied a formal request to Harrisburg which the supervisors signed for the extra money that it will cost for all the road work to PA AVE.

- 1. Supervisor Thompson moved to approve Resolution 2022-4 (amended from 2022-3) transferring Pringle Lane to be the responsibility of Wysox Township. Motion carried with 3 ayes of a roll call vote.
- 2. Citation for Linda Messner was tabled
- 3. Chris Sullivan addressed the board regarding the tennis courts behind the firehall, which are owned by the fire department. Mrs. Sullivan is heading a group who would like to repair the tennis courts, and has found a grant that would help with the cost of these repairs. Said grant has to go through a township. She spoke with the fire department who would be willing to lease the tennis courts to the township and the Township supervisors agreed to look into the cost and insurance responsibilities for the township, the township solicitor will also look into the matter before a decision will be made by the Supervisors.
- 4. Supervisor Them moved to change the August 10<sup>th</sup> meeting to August 11<sup>th</sup> at 5pm Supervisor Gannon second and motion carried with 3 ayes.
