- 1. Supervisor Thompson moved to pass the 2023 Emergency Operations plan update, Resolution 2023-2 Supervisor Gannon seconded and the motion carried with 3 ayes.

- 5. Supervisor Them made an announcement that our 2022 Audit has been completed and all reports filed with DCED.
- 6. The supervisor gave Township Manager Jon Kulick permission to advertise for bid the 2001 F 550 dump truck and plow. This will be advertised in the Rocket Courier and The Daily Review as well as the township facebook page.
- 7. Supervisor Thompson moved to hire Black Knight Quarries for the township property mowing for 2023. Supervisor Gannon seconded and motion carried with 3 ayes.
- 8. Sealed bids for Pringle Lane Road project were opened. Bids were as follows:

Supervisor Gannon moved to award the bid to Chilson Brother's Paving in the amount of \$24,995.00 contingent upon our attorney review of the contract and approving. Supervisor Thompson seconded and motion carried with 3 ayes.

Supervisor Thompson moved that the money to pave Pringle Lane be paid from the Capital Reserve fund. Supervisor Gannon seconded and motion carried with 3 ayes.

9. Sealed road bids for the 2023 Seal coat project on Glen Road, Dry Run Road and Fall Run Road, were opened. Bid results are as follows:

Supervisor Thompson moved to hire Midland Asphalt following a review and approval by our Solicitor. Supervisor Gannon seconded and motion carried with 3 ayes.
