MINUTES OF THE REGULAR MONTHLY MEETING

May 10, 2023

Chairman William Them called the regular meeting to order at 5:00 PM.

Supervisor Thompson moved to approve the minutes of the previous regular meeting held on April 10, 2023 as well as the minutes from the special meeting held on April 18, 2023.

Supervisor Gannon seconded and motion carried with 3 ayes.

Charlie Muchichko in regard to the "No Jake Brake" signs along the Golden Mile specifically near the Lanning Creek intersection needs to have more signs prohibiting the use of Jake Brakes along that section of Rt 6. Township Manager said he would again check with PA DOT, but they had advised the township before where to place the signs.

5. Supervisor Gannon moved to approved the resignation of tax collector Brenda Benjamin who moved out of the township. Supervisor Thompson seconded and motion carried with 3 ayes.

Supervisor Thompson moved to appoint Tina Buchi-Sabina as tax collector for the remainder of 2023. Supervisor Gannon seconded and motion carried with 3 ayes.

6. CBPA- by-laws change was tabled to the June 14th meeting
7. The Supervisors approved township solicitor Chris Jones advertise and draft a resolution stating the township will not have an elected auditor for Wysox Township.
