

RESOLUTION No. 2023-06

A RESOLUTION OF TOWNSHIP OF WYSOX, BRADFORD COUNTY, PENNSYLVANIA, SETTING FORTH ITS DECISION AFTER THE PUBLIC HEARING ON THE REQUEST BY TOPS MARKETS LLC FOR THE INTERMUNICIPAL TRANSFER OF A LIQUOR LICENSE INTO THE TOWNSHIP OF WYSOX PURSUANT TO THE PENNSYLVANIA LIQUOR CODE.

WHEREAS, a request was made by Tops Markets LLC seeking the approval of the Township of Wysox for the intermunicipal transfer of a liquor license, specifically, restaurant license R-18603, into the Township of Wysox pursuant to the criteria as set forth by the Pennsylvania Liquor Code;

WHEREAS, pursuant to the Pennsylvania Liquor Code a public hearing was scheduled on December 13, 2023 at a time of which would be immediately after the regular scheduled township meeting and proper notice was advertised for said public hearing pursuant to the Pennsylvania Municipal Planning Code;

WHEREAS, consistent with the Pennsylvania Liquor Code a public hearing was held before the Township Supervisors in order to receive comments and recommendations of interested individuals residing within the municipality concerning the applicant's intent to transfer the liquor license into the Township of Wysox;

NOW, THEREFORE, BE IT RESOLVED, it be it resolved and it is hereby resolved as follows:


1. After public hearing was held on December 13, 2023 regarding the request by Tops Markets LLC for the intermunicipal transfer of the restaurant liquor license R-18603 into the Township of Wysox, and after receiving comments and recommendations of interested individuals who reside within the municipality, the Township by unanimous/~~majority vote~~, approves/~~disapproves~~ the request by Tops Markets LLC for the intermunicipal transfer of the restaurant liquor license R-18603 into the Township of Wysox.
2. If any sentence, clause or section or any part of this Resolution is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parties of this Resolution.
3. Any Resolution or parts of Resolutions which are contrary to or in conflict with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect.

4. This Resolution shall take effect on the date of enactment set forth below.




