## RESOLUTION 2019-03

## THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF WYSOX HEREBY RESOLVES AS FOLLOWS:

WHEREAS, Under the Second Class Township Code the Wysox Township Supervisors can recognize an ambulance service for the Township.

## WHEREFORE,

The Wysox Township Supervisors recognize the Guthrie Towanda Memorial Hospital Ems as providing service in the Township of Wysox, Bradford County, Pennsylvania, and hereafter known as the "ambulance service" is hereby designated as and officially recognized as the primary ambulance service for the Township of Wysox. However Wysox Township reserves the right to name/rename the ambulance service each year at their annual reorganization meeting.

WHEREAS, The Wysox Township Supervisors can authorize activities for the ambulance service.

## WHEREFORE,

- A. The ambulance service recognized by the Township of Wysox is hereby authorized to provide such services to the Township of Wysox as may be necessary for the protection of property and persons therein, which includes, by way of example and not of limitation, the transportation of persons to and from medical facilities and residences, the extrication of persons from hazardous situations of entrapment, automobile accidents, medical emergencies, hazardous materials incidents up to an operations level or other situations.
- B. The ambulance service may also provide nonemergency and public service functions, such as, again by way of example and not of limitation, standbys at public and private events such as sporting events, community events and assisting in removal, abatement and prevention of damage or injury to persons or property, whether through natural causes or man-made situations.
- C. The ambulance service may also conduct and participate in such training activities and drills, either in or outside of the Wysox Township, as may be deemed necessary by the officers of the department to maintain proficiency in providing service.
- D. The ambulance service may also respond to calls and provide services to municipalities outside of the Township of Wysox pursuant to mutual aid agreements, licensor agreements or legislative requirements.

WHEREAS, The Wysox Township Supervisors can authorize additional activities for members of the Ambulance Service.

WHEREFORE, In addition to actually participating in the activities of the ambulance service as authorized above, or in going to or returning from any activity, the members of the ambulance service, recognized by the Township of Wysox, are also authorized to do the following:

- A. Engage in any type of drill, training, ceremony, contest, practice, test, parade, public education or inspection when duly called for or authorized by an officer or officers of the ambulance service.
- B. Engage in fund-raising activities for the ambulance service, when authorized by an officer or officers of the ambulance service.
- C. Engage in the performance of any duty or activity authorized by an officer of the recognized ambulance service.

WHEREAS, The Wysox Township Supervisors can recognize an Ambulance Service for workman compensation purposes.

WHEREFORE, The Wysox Township Supervisors recognize the Guthrie Towarda Memorial Hospital Ems., volunteer members for workmen's compensation purposes.

THIS RESOLUTION shall take effect immediately upon adoption.
