Supervisor Gannon moved to approve the minutes of the previous regular meeting held on April 10, 2024. Supervisor Franklin seconded and motion carried with 3 ayes.

New Business:

- 1. The supervisors discussed and decided to postpone the grand opening of the Wysox Township Park to after Phase III is completed.
- 2. Supervisor Gannon motioned to use ACT 13 funds for the cameras at the Wysox Park. Supervisor Franklin seconded and motion carried with 3 ayes. The Treasurer will get a down payment out to Teledair on Thursday, May 09, 2024 to get the project started.
- 3. Supervisor Gannon motioned to accept the grant from Bradford County Conservation District's grant for Glenn Road and the remained amount of the project, \$18,179.00 will be paid for from the townships Capital Reserve Fund. Supervisor Franklin seconded and motion carried with 3 ayes.
- 4. Road Bids for sealcoating were opened and results are as followed :

Midland Asphalt Materials - \$ 207,511.85 Suit – Kote \$ 190,214.50 Vestal Asphalt \$ 230,635.00

Supervisor Gannon motions to accept the lowest bid from Suit-Kote in the amount of \$190,214.50 pending our solicitor's review. Supervisor Franklin seconded and motion carried with 3 ayes.

The Supervisors went into a short executive session to discuss some legal matters.

- 5. Supervisor Them motioned to declare Article III, page 74 of the zoning ordinance invalid as to the use of a power generation facility being not permitted in any district except for the Manufacturing district as a special exception and further direct a resolution be drafted to cure said invalidity withing 30 days. There will be a special supervisors meeting held on Tuesday, May 14, 2024 at 5pm to act on this motion. Supervisor Gannon seconded and motion carried with 3 ayes.
- 6. Supervisor Them makes a motion to direct Solicitor Jones to draft a Solar Ordinance for the supervisors to review and discuss, Supervisor Gannon seconded and motion carried with 3 ayes.

Supervisor Them moved to adjourn the regular meeting, Supervisor Gannon seconded and the motion carried with 3 ayes. Meeting Adjourned at 5:57pm.
