Supervisor Gannon moved to adjourn the executive session that took place after the May 14<sup>th</sup> special meeting. Supervisor Franklin seconded and motion carried with 3 ayes.

### **New Business:**

1. The supervisors discussed whether the township would like PA DOT to include sidewalks in the plans for the intersection at Rt 187 and Rt 6. The supervisors would like to see sidewalks included in the plans.
2. The supervisors discussed having Kali's Mission conduct another trap and spaying/neutering and return within the township. They would like to use the shed at the township garage to house the trapped cats overnight. The supervisors instructed Township Manager, Jon Kulick set up a time with Kali's Mission and get prices for the next meeting.
3. Supervisor Them motioned to accept and sign the Kulick subdivision with no adverse comments, Supervisor Gannon seconded carried with 3 ayes. Supervisor Them motioned to allow him to sign as Chairman instead of Township Zoning officer, Jon Kulick, considering that the subdivision is for Jon Kulick's property. Supervisor Gannon seconded and motion carried with 3 ayes.
4. The Supervisors discussed the purchase of an electric sign for the front of the building along Lake Road. Township Manager, Jon Kulick has received quotes roughly \$24,000 along with some examples from a company. Said company also provides service once the sign is installed. The Supervisors tabled the discussion until July 2024 meeting.

Township Manager, Jon Kulick announced that the cameras at Wysox Park have been installed and are now in use.

Supervisor Gannon moved to adjourn the regular meeting, Supervisor Franklin seconded and the motion carried with 3 ayes. Meeting Adjourned at 5:18pm.
