ORDINANCE NO. 2024-<u>000</u> TOWNSHIP OF WYSOX BRADFORD COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING ARTICLE III, TABLE 306.1 OF THE WYSOX TOWNSHIP ZONING ORDINANCE NO. 2020-01 AS IT PERTAINS TO POWER GENERATION FACILITIES

WHEREAS, by way of Resolution No. 2024-04 dated May 14, 2024, the Board of Supervisors of the Township of Wysox declared that Article III, Table 306.1 listing a Power Generation Facility as a special exception in all Zoning Districts was invalid;

WHEREAS, in order to correct said invalidity, the Board of Supervisors of the Township of Wysox hereby amends Article III, Table 306.1 of the Wysox Township Zoning Ordinance No. 2020-01 as it pertains to Power Generation Facilities to state that a Power Generation Facility is a use that is Not Permitted in all Zoning Districts with the exception of the Manufacturing District where it would be permitted as a Special Exception;

NOW THEREFORE, the Board of Supervisors of the Township of Wysox, Bradford County, Pennsylvania, do hereby ENACT AND ORDAIN that:

1. Article III, Table 306.1 of the Wysox Township Zoning Ordinance as it pertains to Power General Facilities shall be amended to state as follows:

- 2. This Ordinance amending Article III, Table 306.1 of the Wysox Township Zoning Ordinance No. 2020-01 shall take effect immediately upon adoption and shall be added to and incorporated with the said Wysox Township Zoning Ordinance.
- 3. The part of the Wysox Township Zoning Ordinance 2020-01 dated February 12, 2020, that conflict with the provisions of this amendment are hereby repealed.

4. All remaining parts of the Wysox Township Zoning Ordinance 2020-01 and any subsequent amendments thereto that are not amended by this Ordinance hereby remain in effect.
