Supervisor Gannon moved to approve the minutes of the previous regular meeting held on October 9, 2024. Supervisor Franklin seconded and motion carried with 2 ayes.

## **Old Business:**

- 1. Supervisor Gannon moved to enact Ordinance 2024-002 Amending Article III Table 306.1 of the Wysox Township Zoning Ordinance 2020-01 as it pertains to power generation facilities. Supervisor Franklin seconded and motion carried with 3 ayes.
- Supervisor Gannon moved to move forward with the Zoning Ordinance Amendment (Solar and Power Generation Facility scheduling a public hearing on February 12, 2025 following the Supervisors meeting. Supervisor Franklin seconded and motion carried with 3 ayes.

3. Supervisor Gannon moved to approve Supervisor Them to sign the Hollenback Land Development paperwork for Bradford County. Adverse comment was that there is no language in the land development concerning a 15-foot width sufficient to accommodate emergency services vehicles, or demonstrate that the turning radii on the road can accommodate emergency services vehicles. Supervisor Franklin seconded and motion carried with 3 ayes.

## **New Business:**

- 1. Supervisor Gannon moved to commit \$50,000 as secured cash for ramp project from the ACT 13 account. Supervisor Franklin seconded and motion carried with 3 ayes.
- 2. Supervisor Gannon moved to approve Resolution # 2024-08 regarding the proposed boat ramp as presented. Supervisor Franklin seconded and motion carried with 3 ayes.
- 3. Supervisor Gannon moved that William Them as chairman, on behalf of Wysox Township, is authorized to sign the Statewide Public Access Grant Program Application requesting a grant in the amount of \$205,600 to construct a new boat ramp. Supervisor Franklin seconded and motion carried with 3 ayes.
- 4. Supervisor Gannon moved to approve the Schoonover subdivision. The only comment made was that the subdivision is in 2 separate townships. Supervisor Franklin seconded and motion carried with 3 ayes.
- 5. Supervisor Gannon moved to advertise the proposed 2025 budgets making them available for public review on our website and at our office. Supervisor Franklin seconded and motion carried with 3 ayes.
